

Mock Stock is an excellent platform to enhance the practical knowledge of concepts in Accountancy and Business Studies in Commerce students.


It gives a feeling of actual trading in the market, enhances the skill of negotiating, convincing and selling along with loads of fun for the participants.

The students mirror the movements of the stock market through paper or electronic means. Thus, the teams learn about the stock market and its movements without losing any physical money.

Lets play the Game as a competition and emerge with maximum profits or.....with minimum losses.

Rules of Mock Stock Competition:

- The teams will join through ZOOM platform for the competition. The link will be sent by email and the students will join with their name followed by the school name.
- 2. The teams should have created an id on the website www.dsij.in. They will start with virtual cash of Rs. 10,00,000.
- 3. The participants will set up their folio at 9:00 am and will share their screen on ZOOM platform after showing the website with their login ids at 9:15am one by one.
- No previous shares should be shown in the Portfolio. If found so, then the team will be disqualified from the competition.
 - 5. They will buy or sell shares of any company listed on BSE or NSE only. The trading time will be 9:30am-11:00am.



- The Profits earned by the team at the end will be calculated to declare winners.
- 8. Profit will be considered for the intra-day trading only.
- The judges' decision shall be taken as final.
 - 10. If any network issues happen, then the team should report immediately to the Event incharge and they may continue their trading and can send the screenshot by Whatsapp or email.

2. MYTH-O-MANAGEMENT

(MANAGEMENT LESSONS FROM INDIAN MYTHOLOGY)

Class: XI & XII
No of participants: 2
Time Duration:3-4 mins
Mode of submission: Video

'Mythology is not the past. They are timeless ideas presented through stories'

Indian mythology is one of the richest elements of Indian culture.

An interesting aspect of the stories and characters in Indian mythology is that they are usually meant to convey subtle facts, rules and maxims to guide all decisions in life including management.

Your challenge is to relate a particular mythological character/incident/anecdote with a concept of management and present it in the form of a creative video entry.

Rules of Myth-O-Management:

- The participants have to make a video of not more than 4 minutes explaining the relevant concept of management.
- 2. The students will make use of PPT as a tool/ medium in the video. Any obscene content will lead to disqualification.
 - The participants are not allowed to disclose any personal information such as name, School, contact details etc. in the video.
 - 4. Upload entry videos on YouTube under the 'UNLISTED' category and mail the video link at vanijya2020@gmail.com by 10th December 2020.
 - The decision of the judges will be final and binding.
