The Directorate of Education, Govt. of NCT of Delhi has issued instructions on 31<sup>st</sup> August, 2021 to call students of classes IX-XII on voluntary basis to conduct regular classes. This is subject to your consent, following the enclosed Standard Operation Procedure (SOPs). These classes are meant to cover the learning gaps which arose during the online classes and to complete the syllabus for the forthcoming exams. The school plans to hold the First Term Examination/Pre Board in the offline mode. The offline classes shall be held twice a week for each grade in school from 8:15 a.m. to 12:45 p.m. and continue online for the rest of the week. The offline classes will be held as per the following schedule:-

Classes IX & X – Monday & Tuesday Classes XI & XII – Wednesday & Thursday

Please note that online teaching will remain suspended for each class on these two days of offline classes. Practical classes shall be held on Fridays turn wise wherever required. No transport facility can be provided by the school. The schedule for the offline classes will be shared with you in the parents' group.

In case, you are interested that your ward attends these classes, following the Standard Operating Procedure (SOPs), kindly fill the consent form sent to you by the class teachers through WhatsApp groups latest by 5 p.m. on 4<sup>th</sup> September, 2021.

#### Please note:

- 1. The **Standard Operating Procedure (SOPs)** as instructed by the Government shall be adhered to and all safety precautions shall be taken.
- 2. All students must attend school in summer uniform **OR** white school shirt and plain Blue jeans.
- Students must carry a 'hard copy' of the consent form with them on the first day with their Parents' signature on it.
- 4. Students must wear a mask covering their nose and mouth. They must also carry a spare mask for emergencies.
- 5. Students must carry their personal hand sanitizers, drinking water and food. The school canteen will remain closed. Sharing of food and water is not allowed.
- Students must carry their own books, notebooks, practical files and stationery items. Sharing of any kind is not allowed.
- 7. Students with cough, cold, fever or any other ailment must not be sent to school during this time.
- 8. Students should refrain from touching eyes, nose or mouth, exchanging stationery and touching any other surface.
- Students must monitor their own health while in school and immediately inform their teachers in case of any illness.
- 10. Students are expected to adhere to COVID APPROPRIATE BEHAVIOUR (CAB) guidelines issued by school from time to time.
- 11. The students are expected to come to and go from school on their own.
- 12. Students are allowed to carry mobile phones to school. They need to deposit the same with their respective Class Teachers before the school starts and take it back after the school gets over.
- 13. Students will enter and exit the school from Gate no. 3 (Near DDA Park).
